Wolff's Flea Market follows laws to maintain a safe, family environment. Please read permit rules & check wolffs.com for updates as we conduct ongoing research. By selling at our market you agree to follow our rules. Vendors not following rules or directions from staff to **immediately & permanently** remove banned/counterfeit merchandise run risk of ejection. Items must be placed **out of sight** (in trunk & not outside vehicle or under table), must not be sold, visible or accessible to the public.

INSPECTION

All booths are inspected. Your information has been recorded & this slip issued. We appreciate your cooperation and self-monitoring of merchandise.

OTHER

- No novelty lighters, used mattresses, open cosmetics, profane, pornographic material including but not limited to magazines & movies. No tarot readings, catalog sales, loaded streaming devices

NO COUNTERFEITS

- It is **ILLEGAL** and punishable by law to sell counterfeit merchandise. Even 1 item, even if customer wants it, even if cheap, even if you tell customer it is fake.
- Not allowed: altered logo, **infringing SVG creations**, confusingly similar, trademark, copyright, license infringing merchandise (new/used) in every category including and not limited to phone accessories (Apple/Samsung), face masks, packaging, DVDs, CDs, Music, Purses, Licensed Sports Items, Shoes, Clothing, Electronics, Cosmetics, Perfume, Sunglasses, Toys, Jewelry, Household items, ETC.
- If we see certain new/used/real brands, we require removal because WE DO NOT AUTHENTICATE. **Examples: Coach, Louis Vuitton, Gucci, Beats/Dr. Dre, Chanel, MAC, OtterBox, Kat Von D, Kylie Cosmetics, Yeezy & others at our discretion.** This rule is non-negotiable.

Counterfeiting is world-wide, & online. Flea markets are liable for allowing counterfeits. Sellers are arrested for selling them. Google "counterfeit + flea market" for busts, lawsuits (Coach/Louis Vuitton/Michael Kors).

BANNED

- No N-95 masks, unlicensed cloth masks, no COVID cards/tests
- No CBD, vaping products, liquor, tobacco, drug paraphernalia, hookahs
- No homemade, prepared, perishable food, no cold drinks (drinks contracted to concessions)
- No fireworks, weapons, parts of weapons, knives over 3", air, pellet/BB guns, toy guns w/o orange tips, pellets, ammunition, swords (decorative/collectible), paint guns, crossbows, bows, arrows, ETC.) pepper spray, stun guns, tasers
- No animal sales or ads for selling animals
- No items requiring prescriptions, controlled substances, contacts
- No prejudicial, profane, disinformation, offensive, inflammatory, insulting literature or merchandise (Nazi, Confederate, symbols)

BABY ITEMS

Due to safety & recalls, no NEW/USED infant/child car/booster seats, cribs, crib mattresses, portable cribs, sleep positioning devices, bassinets, "pack & plays", playpens, strollers, highchairs, booster chairs, bouncy seats, baby formula, baby swings, wheeled walkers, baby seats, ETC.
